**NEW LEBANON** Barking, Bathrooms and **B**roadband

Proposed Local Law #1 of 2021 was approved at the April 13 New Lebanon Town Board meeting. The Law, which identifies what constitutes a dog causing a disturbance due to habitual barking etc., will now be sent to the New York Secretary of State for filing. The Pavilion Bathroom contract has received an extension until the end of May. All of the supplies are ordered and the project is coming along nicely. However, FRP panels that are part of the project can only be installed when the temperature is above 50 degrees consistently for a period of about two weeks. The panels should be able to be installed in early May.

New Lebanon is seeking a Community Project Funding Grant for Broadband along with Austerlitz, Canaan and Ghent. The four towns will work together to apply for funding to provide broadband to all unserved or underserved households in these towns.

New Lebanon's share of the cost could be zero, or could come out of COVID-19 funding or maybe a future town budget line item. For now the Board is simply looking for approval to apply for the grant through Congressmen Antonio Delgado's office. If approved, then the amount New Lebanon would need to contribute would be determined and the town could then decide to move forward or not.

The Board is looking into the possibilities of what a potential 33 acre land donation to the town can be used for. Some suggestions were for a kayak launch, town swimming area, and of course, fishing. The property runs along Wyomanock Creek. A strip of land that is currently owned by someone else separates 17 acres of the land from the rest, however the town is going to look into the possibility of obtaining that piece of land so there would be no break in the donated property.

New Lebanon is waiting for guidance from the Treasury Department on how it can delegate incoming Federal funding. Once that guidance is received, the Board would like to schedule a public input session to get ideas as to what people would like to see done with the money. Some suggestions from the Board included helping people and small businesses who have suffered hardships during the COVID-19 pandemic and improving infrastructure.

An internet upgrade at the LVPA will allow events to be livestreamed for those who still may not feel comfortable attending meetings in person.

The owners of a new potential business on Darrow Road have met with the Planning Board. However, input from the Town Board was necessary as the property and much of the surrounding property pre-dates current zoning laws. The property in question is said to already be used for the same purpose the new business would be, but what that business is wasn't specified. A motion to move the possibility of rezoning along Darrow Road to the Zoning Rewrite Committee was approved.

U.S. Representative Antonio Delgado (D-NY-19) and Representative David B.
