PFOA, PFOS, GenX, and many other chemicals. PFAS have been manufactured and used in a variety of industries around the globe, including in the United States since the 1940s. PFOA and PFOS have been the most extensively produced and studied of these chemicals. Both chemicals are very persistent in the environment and in the human body – meaning they don't break down and they can accumulate over time. There is evidence that exposure to PFAS can lead to adverse human health effects including cancer.

Picking A New Water Source

Identifying a new source of drinking water for Hoosick Falls has been an ongoing project by the NYS Department's of Health and Environmental Conservation. They have narrowed it down to five possible sources, and Mayor Allen expects the state to make a recommendation on which they think is best within the next two weeks. After that, the state will conduct an open public comment period, also discussing their findings with village and town officials before making a final decision.

the installation closer to his home. When shown it did not impact his residence, he had no other comments.

Tamarac Solar also told the combined boards the installation would only require two power poles and two transformer pads, lessening that part of any visual impact. They also spoke about a virtual public information session they recently held, in which 29 people participated. According to their spokesman, the majority of those online that night supported the project. The matter was then put on the agenda for the Planning Board's April 15 meeting for further discussion.

Cole Lane Major Subdivision

Jim Cillis is asking the planners for permission to break his 16.2-acre parcel into 15 housing lots, with connecting road. He was not at the meeting, and the Planning Board is uncertain if he has already obtained a waiver for the amount of homes on a cul-de-sac. Brunswick Codes limit this number to 12, unless approved by the Town Board. It has become a subject of research before the next meeting.

Hannaford Wants To Make It All Right

We're not talking about a transgression here, but simply how trucks will enter and leave Lord Avenue, while bring in a copious amount of fill. How much? Hannaford says about 90 to 100 trucks a week, for four to five weeks.

At the last meeting, the grocery store chain said trucks would be coming west bound on Hoosick Road (NYS Route 7), and turning right onto Lord Avenue. The problem the planners expressed was with these trucks leaving Lord Avenue and turning left back onto the very busy Hoosick Road. Planners expressed the desire for some sort of traffic control. At Thursday evening's meeting, Hannaford said it has decided to have the exiting vehicles turn right on Hoosick Road, travel to Route 40, and turn right once again to head north. Problem solved? Time will tell.

The Planning Board also declared itself lead agency for the SEORA review, as no other agencies involved in the permitting process want to take on that task.

This is another of what the Planning Board has taken to calling a "ping pong proposal." Once and if the SEQRA is approved, the matter must then go before the ZBA for a variance request, and then back to the Planning Board for final consideration.

What About Aldi

If you will recall, the Planning Board gave the SEQRA review a thumbs up at its last March meeting. The David Leon backed development still needs a ZBA variance, making this yet another "ping pong proposal." Unlike the Planning Board, which meets twice a month, the ZBA only meets once, and that meeting was prior to the SEQRA approval. The way the April Planning Board meetings fall, it will have met twice before the ZBA gathers again. So, if at its April 19 meeting, the ZBA approves Mr. Leon's variance request, the project might be back before the Planning Board at its first May meeting.
