SCHODACK **A Potpourri Of Topics** For The Town Board

After the Schodack Town Board came out of executive session on April 22 it got right to work passing resolutions, discussing COVID-19 restrictions and paying tribute to a beloved former member of the Planning Board.

Supervisor David Harris started the meeting by "extending condolences" to Homer relative to medical and hospitalization LaVoie's family. He passed away at home on April 14 at age 90. LaVoie was a wellrespected member of the community and served nine years on the Planning Board, two as secretary. LaVoie authored Born in a Boathouse, an autobiography about growing up on Tupper Lake in the Adirondacks.

On Thursday, May 13, a public hearing will be held at 7:05 pm at the Route 9 Business Park on a portion of land owned by Donald Hart and Hartland Associates Inc. The Board approved the resolution, which allowed for "the adoption of proposed local law No. 2 of 2021 amending the Town of Schodack Zoning Code and creating a new Planned Development District." The Board also approved a memorandum of agreement between the town and the United Public Service Employees Union (police unit) coverage. The approval of Resolution 140 allows current employees hired after 2001 to have the town pay 75% of the cost of individual coverage, and retiree benefits will essentially remain the same.

The final discussion revolved around trying to update COVID-19 regulations and procedures at the Town Hall. The Board is reviewing material on two filtration units that could be used to filter out microorganisms. The Board will further peruse the information at its May 13 meeting.
