These two areas are the focus of a new initiative to expand high-speed service with some funds available from state and federal sources. 
The food was donated and the event made possible through a partnership with the Regional Food Bank of Northeastern New York.

### CHATHAM Albany Man Accused Of Rape Submitted by the CCSO


Sheriff David P. Bartlett reports that the Columbia County Sheriff's Office arrested Juan Tyler-Diaz on May 6 and charged him with Sexual Offenses.

Investigator Joshua Oakes and Investigator K.C. Bauhoff began the investigation after receiving a referral of misconduct and sexual acts with minors. During

the course of their investigation it was discovered that there were two victims in this case that made disclosures indicating Tyler-Diaz.

In this particular case, the alleged sexual acts occurred in the Town of Chatham ranging back from April 2021 over the course of a few days when the victims were between the ages of 13 and 14 years old.

Tyler-Diaz, 22 years old from Albany, was arrested for Rape 1st Degree, a class B Felony, Rape 2nd degree, a class D Felony, two counts of Forcible Touch-



Tyler-Diaz was arraigned in Chatham Town Court in front of the Honorable Justice Borgia-Foster, where an order of protection was issued for the victims in this case. Tyler-Diaz was remanded to the Columbia County Jail in lieu of \$1000

cash or credit or \$5000 bond. He is due back in Chatham Town Court at a later date.

The Sheriff's Office was assisted in this investigation by the Child Advocacy Center of Columbia-Greene Counties, and the Columbia County District Attorney's Office.

The investigation is continuing and Sheriff Bartlett urges anyone with information regarding this individual to contact Investigator Joshua Oakes of the Criminal Investigation Branch at 518-828-3344.
