## **Three Cars Crash** Two People Injured On Route 7

According to New York State Police, two people were sent to an area hospital for treatment of nonlife threatening injuries, following a three car crash on NYS Route 7 near Upstate Auto Sales in Pittstown on Tuesday afternoon, May 4. The crash also closed part of the road for a short while.
