Local Woman Ran From Police, Now Faces Many Charges

On Wednesday, April 21, Hoosick Falls Police attempted to execute a warrant issued by Rensselaer County Court on a Lecia Edghill, age 41, of 3 3rd Street in the Village. The warrant issued by a Rensselaer County Judge was for Failure to Appear on a prior Assault charge. Officers stopped Edghill, who was driving a 2003 Ford Explorer, and upon being advised that she was under arrest, she drove away, knocking an officer to the ground.

An arrest warrant was issued for Assault 2nd of a Police Officer and on Thursday April 29 she was located and arrested. She was charged with:

- Assault on a Police Officer
- Aggravated Unlicensed Operation of a Motor Vehicle
- Failure to Comply
- Resisting Arrest
- Obstructing Governmental Administration
- Operating a motor vehicle without insurance
- Expired Registration

Ms. Edghill was arraigned in Village Court and remanded to the Rensselaer County Jail to appear in County Court at a later date.
