Grafton Man Charged With DWI

On May 22 the New York State Police in Sand Lake arrested 31-year-old Cory Bly of Grafton, for Driving While Intoxicated- Previous Conviction, a class E felony.

At approximately 3:08 pm on May 13, State Police responded to a one-car motor vehicle accident on State Route 22 in the Town of Berlin. On scene investigation determined that Bly had been traveling south on State Route 22 when he veered off the western side of the roadway and struck a tree.

While the trooper was speaking with Bly, they could smell the odor of an alcoholic beverage and observed signs that he was intoxicated. Bly refused all tests to determine the alcohol content of his blood. He was transported to Albany Medical Center for treatment.

Bly turned himself in for processing at SP Sand Lake and was issued an appearance ticket for Berlin Town Court on June 26.

Duncan Maclean Arraigned For 2017 Assault

Rensselaer County District Attorney Mary Pat Donnelly announced on Wednesday, May 26 that an indictment was handed up on Friday, May 21 for Duncan Maclean, age 37, previously of Pittstown. Maclean was charged with one count of Attempted Murder in the Second Degree, a class B violent Felony, one count of Assault – 1st Degree, a Class B violent felony, one count of Attempted Assault in the 1st Degree, a class C felony (1), one count of Assault in the second Degree, a class D violent felony.

Maclean is accused of attacking his victim with a hammer in late 2017.

"I am pleased that the courts have re-opened so we were able to present this case to a grand jury. We are one step closer to justice for his victim," said District Attorney Mary Pat Donnelly.

Maclean was arraigned in front of Judge Young, and held on \$50,000 bail. Chief Assistant District Attorney Matthew Hauf presented the case to the grand jury.
