

# **Developer Unveils Plans for** Additional Business at Aldi Site

ing Thursday, April 7, David Leon's representatives asked the Board to approve what they labeled a minor build out change for the site of the proposed Aldi, Wendy's and KFC, now under construction along Hoosick Road (NYS Route 7). The change, however, now includes the construction of a fifth building on the site for an Aroma Joe's Drive-Thru Coffee (the Planet Fitness building already exists). Other proposed changes include a redesign of the Wendy's building and parking space alterations and the installation of four electric vehicle charging stations.

Board members expressed concern thinking this was indeed a major site plan change that might well involve a detailed SEQRA review as well as another public hearing. Board Attorney Andy Gilchrist indicated he would look into the legalities

At the Brunswick Planning Board meet- of the changes and what under Brunswick law they might entail reporting back to the Board at their April 21 meeting.

### **Belair Lane Solar**

The meeting began with a joint public hearing on CVE North America's application to construct a solar energy farm on land off Belair Lane. The project has faced many challenges including a need for rezoning, which was approved last month by the Brunswick Town Board. The public hearing held this night in combination with the Zoning Board of Appeals (ZBA) saw but three speakers, two neighbors of the project who had some visual concerns, the other a resident of the Town but not a neighbor who was concerned with the use of approved pesticides, urging the use of goats to keep grass levels down.



# GRAFTON **Further Discussion Required**

At the April 11 regular meeting of the Grafton Town Council, EMT Services NY LLC (EMTS) gave a presentation in which they detailed their current partnership with the Grafton Rescue Squad (GRS). The agreement between the two is currently on a consultation basis, for such things as assessing best practices and bylaws in order to make sure the ambulance station is in compliance. EMTS also discussed the possibility of extending the agreement with GRS to include staffing services, mentioning some of the reasons this would be beneficial, such as alleviating pressure on current volunteers so they don't get burned out.

For July through December of this year, the cost of staffing services from EMTS would be \$55,000 to cover five 12 hour shifts per week, and \$63,000 for six 12 hour shifts, plus an additional \$18,000 for operating expenses.

Since the rates listed previously are only for the last six months of 2022,

the number would have to at least be doubled for 2023 and beyond, at current rates. There is no locked in price, and cost increases are possible from year to year.

The Council stated they will need to discuss the matter further before a decision can be made, and would like public feedback before doing so. For that reason, it's very likely this topic will be discussed at an upcoming workshop meeting, and even possibly a public forum.

# HOOSICK FALLS Residency Becomes Part of the Police Review Board Debate

Last spring, following an executive order from former Governor Andrew Cuomo, the Hoosick Falls Village Board formed a committee to begin a review of the policies and practices of the Village Police Department. Part of their report was the suggestion the Village form a Civilian and Reform Board to assist and advise the department, though they would lack any regulatory powers. To that effect, a local law was drafted and a public hearing on such was held at their Tuesday, April 12 meeting. There were no speakers.

Later in the evening, when it came time to vote on the law, Trustee Megan Walraed asked if it was true there was a clause in the law that would allow nonvillage residents to serve on the Board. The answer, according to Village Attorney Andy Gilchrist, was yes. There are some specific conditions to this service, in general being the person in question would have to possess qualifications or experience that made their service desirable. That would only come about if the Village Board was to grant a waiver of residency. Ms.Walraed was joined in her apprehension to this clause by Trustee Deb Alter, with both voting against the new law. It passed however, with four yes votes. Mayor Allen feeling poorly through the evening, left for home before the vote. The actual appointments to the Board will take place at the Organizational Meeting on Monday, April 25 at 6 pm.

#### Budget

There was also a public hearing, again with no speakers, on the 2022-23 Village budget, which contains an approximately 1 percent tax hike, under the NYS Tax Cap. The final vote on the budget will also take place at the April 25 gathering.

#### **PFOA Study**

Dr. Erin Bell of the NYS Department of Health spoke at the meeting about a multi-site PFAS Study that includes those exposed to PFOAs. A lab has been established in Hoosick Falls at 150 Main Street. The Hoosick Falls portion of the study is also open to Petersburgh residents. Researches will be looking closely at the role PFAS may play in various health outcomes by analyzing results from blood tests, health-related lab tests along with medical and expo-

#### **Classic Street Sidewalk**

Trustee Kevin O'Malley mentioned the troubling spot on Classic Street (NYS Route 22) was simply getting worse with little hope the NYS Department of Transportation was going to do anything about it. The discussion then turned to several other sidewalk woes, with the suggestion made that in the coming year's budget, some of the roadwork monies be diverted to address these issues. Mayor Rob Allen noted the amount of road repaving they planned to do was already being reduced because of the soaring rate for asphalt. As to the Village's ability to address the Classic Street situation, Attorney Gilchrist labeled it "complicated" and said that he would review the rules and regulations concerning such Village involvement.

#### **Other Points of Interest**

Hydrant flushing will take place on *Monday, May* 2 for Wards 2 and 3. The flushing for Wards 1 and 4 is slated for *Tuesday, May 3*. We will publish the dates for street sweeping as soon as they are finalized.

The Louis Miller Museum will hold its Grand Reopening on *Saturday, April 30 from 11 am to 4 pm*, with a ceremony scheduled for 1 pm.

The Little League Parade will also take place on *April 30*, with line up at Wood Park at 9:30 am.

Village Cleanup Day is slated for *Saturday, April* 23 starting at 8:30 am. Volunteers are asked to gather at the Wood Park Gazebo. Bring glovers, rakes, brooms and lots of energy.



# EAST NASSAU Board of Trustees Highlights

The East Nassau Board of Trustees had a busy night on Monday, April 4, with an organizational meeting, a public hearing on the budget and their monthly meeting.

The organizational meeting began with the swearing-in of Mayor Acquario and Board of Trustee member Lydia Davis. The Board approved official appointments that included Kevin Hitchcock as a Code Enforcement Officer, Michael Dorr as Public Works Superintendent, Jeanine McCarthy as Village Treasurer and Diane Maguire as Village Clerk. Trustee Tom Kernan was also appointed as Deputy Mayor. Outgoing Board of Trustees member Mike Lever was approved to be a Zoning Board of Appeals member for a term to end in 2027. Mayor Acquario thanked all of the appointees for their continued work for the Village.

After the organizational meeting, the Board held the public hearing for the 2022-23 budget. The budget included no changes in stipends for the Mayor and Trustees but a three percent increased stipend for the Treasurer, Code Enforcement Officer, DPW Supervisor, Clerk and Village Attorney whose salaries had been frozen for the past two years due to COVID-19. The budget reduced the tax rate per 1,000 assessments from \$1.75 to \$1.66, which is the lowest it has ever been.

At the close of the budget hearing, the general meeting opened with the setting up of a public hearing for *May 11* on a special use permit for a sign at the Country Farm Mini Mart. The Board reviewed information about the sign; some details were still needed, and the applicant is required to submit that informa-

tion by April 29 for the public hearing to commence.

After the Board of Trustees adopted the 2022-23 budget, the treasurer was happy to report that the Village received \$22,000 in sales tax revenue. An updated QuickBooks system was approved for the Village to use, and will be implemented at the beginning of the financial year.

The cookie contest had been scheduled for the end of May but rescheduled for *Sunday, November 13*. After receiving feedback from residents, the Board felt that returning to the original date would be a better fit for the community. Mr. Kernan thought that this year would be the best one ever.

Climate Smart Committee chairwoman Lydia Davis wanted to thank Code Enforcement Officer Kevin Hitchcock for taking a training course that helped the committee complete another step in attaining a \$5,000 grant. The committee is finding sites in the Village for some demonstration water-smart gardens, which will highlight nine bark and the lasagna method of mulching. They also hope to work with the Albert Forest for a community day to help remove invasive species.

Mayor Acquario concluded the meeting by appointing Nick Atchinson to the Board of Trustees, effective May 1. Atchinson expressed an interest in replacing Mike Lever, who will be focusing his time on the Zoning Board and AMVETS. Mayor Acquario thanked Lever for his continued service to his community and described him as being irreplaceable. Atchinson recently moved back to the area from North Greenbush.



# The Life of George Holcomb

## **George Comes Up Lame**

Wednesday, March 10, 1852: I continue to have my foot polticed. Today John F. rode to the Shakers on horseback. He went to engage carrots and turnips.

Thursday: I have the policies continued to be put on my foot and tonight my foot discharged a little bloody where we gave it vent with a pin and the swelling in the foot not so bad. Today Geo P. shoveled snow on the highway a spell, it was an old drift.

Friday: I continue to have my foot polticed and it is better, not swolled today. As Doctor Bates was passing by I had him call and look at my foot. He said I might have it polticed a spell longer. Saturday: I have the poltices continued on my foot.

Sunday: Quite rainy, I have turpentine put on my foot, it not swelled.

Monday: I have honey and egg police on my foot but it did not do any good. Today a brick yard Shaker came and bargained with John F. for a load seed turnips and half one bushel potatoes to see the quality. Today the Irishman that lives in Wm B. Maxon house came and his wife with him and picked up stone in their last fall job.

Tuesday: I have a shoemaker poltice on my foot and today Geo P. started on foot to the east to engage apple trees. Today the Irishman that lives in Wm B. Maxon come and his wife with him and picked up stone. Today I signed one dollar and paid it in cash for the relief of Mr. Canada that sustained a loss by fire, his wadding factory and machin-

ery all destroyed. Wednesday: I continue lame, I went out of the house for the first time in three weeks but I have the poltice on my foot. Friday: I stopped poltice, my foot it continues stiff and painful and some lame. I walked a little on it and I rode up to Wm B. Maxon farm and fetched home a sheep that had a young lamb.

Saturday: I continue lame, I this afternoon took the one horse wagon and carried my daughter Charlotte E. to Hancock to Lapum's store and Charlotte E. traded out what they owed her for making boosums, she bought cloth for a dress and cotton cloth and remnant calico. I called to Mr. Burrels to see if he had got my jug of molasses ready but he had not, and he promised me he would have it ready at Randal Brown's store on Tuesday next.
