
Delgado Appointed Lieutenant Governor

On Tuesday, May 3, New York Governor Kathy Hochul announced she is appointing Congressman Antonio Delgado as Lieutenant Governor. Mr. Delgado, who was first elected in 2018, and is currently in his second term representing New York's 19th Congressional District, will need to resign from that position in order to begin his new role.

In the press release from the Governor's Office, Mr. Delgado is quoted as saying "New York deserves a Lieutenant Governor who's working day and night to make lives better for working people and their families. Upstate, downstate, doesn't matter. We all want the same things: security, family and opportunity. The key is to listen to New Yorkers from all walks of life and then be their voice to get the job done.'

The appointment comes just a day after Democratic lawmakers passed legislation which would allow former Lieutenant Governor Brian Benjamin to be removed from the upcoming ballot due to his indictment stemming from a federal corruption investigation. The recently passed legislation has drawn criticism from Republican lawmakers, who feel Democrats only did so to save Governor Hochul's campaign.

The Republican candidate for the 19th District is current Dutchess County Executive Marc Molinaro. Asked by The Eastwick Press for his reaction to the Delgado appointment, he said "This campaign has always been about finding solutions and making the lives of Upstate New Yorkers better. I will keep meeting voters from all corners of the district and look forward to delivering real results.'



The 2022-2023 budget, which was recently approved at the April 14 Special Meeting, will see an overall increase of 8.95% with a tax levy increase of 1.99%. In addition to the budget, the election will fill two positions on the School Board with expiring terms and contain a proposition to purchase three new 66 passenger buses. The budget and Board of Education vote will take place Tuesday, May 17, from noon to 9 pm, at Berlin Elementary School.

The Board resolved to cast votes for Edmund Brooks, David Finch, Nadine Gazzola and Melony Spock to fill the four expiring term positions on the Rensselaer-Columbia-Greene Counties Board of Cooperative Educational Services (BOCES).

Town Council Highlights

The April 28 Schodack Town Council meeting COVID-19 tests and is looking at ways to distribute was relatively quick, but had many different issues discussed. The Council held a public hearing on a proposed sanitary landfill on Miller Road. The engineering firm presenting the project isn't planning more than one acre of disturbance. They also have a letter from DEC validating the cleanliness of the fill. However, a decision won't be made until the engineering report can be reviewed.

The Council reviewed a proposed Road program for the year to address maintenance throughout the Town. Schodack has also received some more

them. Household hazardous waste day is scheduled for July 31, which the Town will sponsor.

Presently the Town has received \$594,000 in American Rescue Plan Act (ARPA) funds. There was discussion about allocating some of the money for the new bridge, equipment and improvements with Sewer district 5 in East Schodack, but no clear decision has been made

Supervisor Chuck Peter gave members copies of noise ordinances from West Sand Lake and Nassau and asked members to review them. He felt the present policy is a bit light and should be refined.

Supervisor Peter and the Council are working on getting together next month at different sites, such as the Town Park, Police Department, Transfer Station and highway garage, to better understand the updates and necessities these facilities need.

The Board approved posting a listing for a part-time accountant for assistance in the comptroller's office.





Common Serviceberry (Amelanchier arborea) is a delicate tree that is native to the eastern half of the United States growing 15 to 40 feet tall with a trunk diameter of about six inches. The bark is smooth gray. The flowers measure an inch or less. The edible berries produced in the fall are loved by birds and humans.



One of the early showy forest wildflowers is the Red Trillium (Trillium erectum). It is native to the eastern United States and Canada. The flower attracts flies and beetles as pollinators because it has an odor similar to rotting flesh, thus sometimes called Stinking Benjamin. The roots have been used medicinally. The Life of George Holcomb

Geo P. Does a Brisk Business in Apple Trees

Friday, April 23, 1852: I took my one horse wagon and carried my side hill plow to J. B. Maxon's shop and old Mr. Farrington repaired it and I paid him 25 cts and Bliss Maxon soldered my lead pipe. Today Geo P. drew manure on the Maxon farm, and the Irishman that lives there helped him.

Saturday: I took my one horse wagon and carried four bushel wheat and one of corn to Lebanon and left to be ground to Joseph Adams mill and Mr. Sloane put a new shoe on my horse and it pays for the turnips he had last fall. I came home by way of Gay's store and looked our accounts over and found that he owed me one dollar and 68 cts. I then bought nine yards calico at 7 cts per and two pounds batting 24 cts. Today I hired a stranger for one month at ten dollars. he is Irish by the name of Daniel. Today he dug a ditch and filled it from the cheese house to the barn yard. Geo P. carried the pipe to John Mantle and he soldered it over that came apart where Wm B. Maxon soldered it.

Thursday: I measured up twenty bushels of John F. carrots to Lord's hired man, carrots when paid for to be 25 cts per. Towards night John F, and Hiram burning a brush heap fire by accident got in the old hay and burned part that I spread from the stack for foddering. Tonight I paid James Runnals two dollars cash for his four days work.

Saturday, May 1: I took my horse and wagon and carried two hundred grafted trees for Geo P. from his Pierce nursery and delivered to Doctor E. Graves at eighteen dollars per hundred but not paid for. This afternoon Geo P. and his two sisters went to Daniel Rows on a visit. Today John F. measured up two loads carrots and turnips, 57 bushels at 25 cts per and took his cash of the Church family Shakers.

Sunday: Geo P. and his two sisters returned from Nassau from Dryden and Daniel Row's

Monday: I took a one horse wagon and went to Geo P.'s nursery and helped put on a one horse wagon load apple trees and he went to Petersburgh and Hoosic with them and from his nursery I went with Geo P. horse and wagon to Hancock for him to Wm Lapum's and got three bushel of the June potatoes at 50 cts per.
