

# **ARPA Funding Requests**

Petersburgh Town Council three different groups gave presentations to the Council requesting American Rescue Plan Act (ARPA) funds. The first proposal, which was prepared by the Friends of Petersburgh History and submitted by Town Historian Peter Schaaphok, requested funds for the purpose of preserving the original Town record books, if possible, and making a replica and digital copy of the books for public viewing. Items needed include a laptop, scanner and external hard drive. The requested items total \$7,660.37 but an anonymous resident has offered to donate \$3,000 towards the cause.

funds for items such as two sets of horseshoe pits and two sets of pro-style cornhole games for possible fun-

At the Monday, June 20 regular meeting of the draising and tournaments, as well as health and fitness type equipment.

The Fire District and Department requested funds for the purchase of an Argo utility vehicle. Around \$10,000 of the total cost will be picked up by Rensselaer County, which leaves the remaining amount needed at roughly \$25,000. Argos are designed for the purpose of aiding first responders in getting to locations that would otherwise be difficult or impossible to reach. They are amphibious and can be used for water rescue as long as the current is 2 mph or under. The vehicle is also equipped to handle extremely icy conditions, as well as unplowed The Parks and Recreation Committee requested roads and trails. The Council said they will take these presentations into considerations and hope to have answers to the requests soon.

### **Geothermal Bid**

The bid for the Library geothermal project will go to Choice Heating and Cooling of Troy. The total cost of the project will be around \$152,000. This number is roughly \$25,000 more than the estimate last year, due to inflation. Approximately \$94,000 of the cost will be paid for by the State. Due to difficulty getting materials due to supply chain issues, the hope is for an October start to the project, with completion expected sometime around the end of January.

### **New Software**

The Council approved the purchase of new tax collection software that will work with current Rensselaer County software. Petersburgh was the last town in the County to make the switch. The software will require an \$8,300 initial setup fee with a cost of \$3,300 annually thereafter.

# **ARPA Funds Public** Meetings

Poestenkill has received \$230,000 in federal American Rescue Plan Act fiscal recovery funds with an additional \$230,000 anticipated later this year. The Town Board is working to make sure that this money is used in a way that has a lasting impact.

In March Poestenkill held two public meetings to ask for ideas. These listening sessions were so well received that Poestenkill will be holding a second round of public sessions in mid-July.

Many of the comments were about town services and operational issues; Supervisor Keith Hammond has asked Highway Superintendent DJ Goyer to join him in addressing those concerns at the beginning of each July meeting.

The possibility of a town park was the most frequent suggestion in March. It would be helpful to hear more about how residents and their families would use it, where it could be and what facilities and amenities it could have.

# Little Comment **About Code Changes**

It took longer to explain the changes to the Brunswick Town Codes than needed for those who wished to comment on them at the Monday, July 11 Public Hearing. In a nutshell the proposed amendments eliminate any district overlays and reinstate a density calculator. They also make some changes in the amount of buffer space needed between lots, up to 200 feet. Bill Brady, who owns property on Farrell Road, feels this is excessive and unfairly limits the amount of usable land. He suggested that a 50-foot buffer would be sufficient. His comments were echoed by a representative of Rifenburg Construction. The only other comments concerned changes that affect small agricultural operations.

The Board held the hearing open for written comments for 20 calendar days. Their next step is to consider all comments and decide if they wish to make changes to the new codes before approval.

# Residents Leave Solar Vacant Council Seat Filled Hearing Unimpressed

There were lots of questions for the developers of a community solar project located on property off Oakwood Avenue and Farrell Road at a Thursday, July, 7 public hearing and meeting, conducted jointly by the Brunswick Planning Board and the Zoning Board of Appeals. One of these inquiries concerned a tree line shown as a buffer from the project, that residents claimed was no longer there. The applicant, Atlas Renewables, admitted they were using an older image of the site, and that the trees indeed had been removed. Other questions were raised concerning noise generated by the project (minimal according to Atlas), site fencing, the closeness of power poles to Biscayne Boulevard (knows as the Miami Beach estates) impact on wild life and property values. Another major complaint was the professionalism of the Atlas presentation — many speakers labeled it Lego Time confusing and lacking in clear information.

The Planners and ZBA members agreed to close the public session of the hearing but to technically hold it open until July 21 for written comments.

### I See the Light

Developer David Leon and the NYS Department of Transportation (DOT) have been battling for years over the placement of a traffic signal on Hoosick Road (NYS Route 7) at the intersection with Lord Avenue. That is where Mr. Leon is building an Aldi Supermarket, Wendy's Restaurant, Kentucky Fried Chicken and he hopes an Aroma Joe's Coffee Shop. Aldi had refused to commit to the development without that traffic signal.

The whole matter was worked out last year, and everyone (including the new Hannaford Super Market across the road) has been waiting on DOT to install the device. Wait no more. It now hangs above that intersection, just is not activated vet.

Meanwhile, the Planning Board declared there was a negative environmental impact with the addition of the Aroma Joe's, and may give final approval at their next meeting.

### It's a Conundrum

The Brunswick Acres' proposed 24-lot single

housing project has run afoul of the Rensselaer County Health Department (RCDOH), in that 10 of the proposed lots cannot yet be approved for septic, because of the massive amount of grading that must be completed. The developers wanted to split the project so they could go forward with 14 of lots, but it is a unique circumstance and cannot be treated that way under subdivision laws. It was decided at this meeting to move ahead seeking conditional approval, so the grading can be completed, and if the remaining lots eventually meet with RCDOH

### **TROY**

On Thursday, July 7, the members of the Troy City Council unanimously approved Steve Figueroa as the replacement for the resigned Kim Ashe-McPherson. Ms. Ash-McPherson left her seat on the Council after pleading guilty to a voter fraud related charge.

The three Democrats on the Board supported Mr. Figueroa from the start, while the three remaining Republican members wanted to hold open interviews first. Seven candidates expressed their interest in the job, and after talking to all, Council President Carmella Mantello announced her caucus would support Mr. Figueroa for the post.

He will face a special election in November if he desires to fill the remaining portion of the term.

# Making the Classic Street Sidewalk Problem Go Away

Take a walk on Classic Street by Bistro 42 (not their problem) and on the sidewalk there is a mess and considered by many to be dangerous. All year long the Hoosick Falls Board of Trustees has been discussing what to do about it and at their June meeting asked Village Attorney Andy Gilchrist to look into taking the land by eminent domain. The Catch-22 here is that Village Codes talk about unsafe structures being covered by such action, but not neces-

sarily sidewalks. To make sidewalks part of a legal eminent domain proceeding would mean the Trustees would have to change a 2008 local law. Attorney Gilchrist presented the Board with a new law to consider, and introduction of which will most likely occur at a special meeting on July 19. Mr. Gilchrist also explained they need to decide if they just want to take the land around the sidewalk or the entire site, and what would they do with the site after the sidewalk is repaired. All points to ponder.

### **Sewer Vac Truck Bonding**

At the June meeting, the Board voted 6 to 1 to reject a proposal to increase the length of the bond for the recently purchased Sewer Vac Truck from five to 15 years, worried the life of the vehicle may not necessarily be another 15 years, and that they would still be paying for a vehicle long after they could no longer use it. Village Treasurer Denise McMahon was in attendance at the Tuesday, July 12 meeting to explain the fiscal impact on the Village if the change was not made, particularly a large payment that would be due soon, and something that would negatively impact the next year's budget. Her plea did not fall on deaf ears as the Board decided to reverse their previous vote and approve the bonding extension.

It was mentioned by Trustee Kevin O'Malley that perhaps the Village should look to sell their large excavator and use the funds to pay off the vac truck, wondering just how much it is really used. That idea was opposed by Highway Superintendent Niel Stowell. Both Ms. McMahon and Deputy Mayor Bob Ryan expressed concern about the amount of debt the Village is carrying and how to handle it when it comes due.

### **Leachate Pump Replacement**

The Village is under an order by the NYS Department of Environmental Conservation (DEC) to deal with the leachate from the former landfill, now considered a hazardous waste site. Earlier this year, the pump used to collect that leachate failed. It was repaired and managed to pump out 5 million gallons once placed back in service. It has, however, failed once again and the leachate is backing up, with DEC demanding action. The Trustees are looking at leasing a new pump in the short term, and purchasing two identical new pumps, for both redundancy and to split the work load on each pump. There will be a presentation made at the July 19 special meeting.

# Fire Departments Celebrate Their Anniversaries

The 4th of July weekend was twice as special for the Hoosick Falls and North Hoosick Fire Departments, as they celebrated their 175th and 75th anniversaries respectively. Town roads, particularly Wilson Hill Road, was front and center at the Monday, July 11 meeting of the Town Council. According to Town Supervisor Mark Surdam, it is becoming an all too consistent occurrence, with the Council discussing several options to try and deal with it. Signage was one suggestion but would the perpetrator(s) pay any attention to them? Probably not.

The Town does have a dumping ordinance; conviction of such a violation carries a \$1,500 fine. The Councilors decided to try and get the word out about the dumping any way they can — social media, news media and word of mouth. ### **Meeting News and Notes**

There is a request by the Water Department to purchase land on Ashley Drive, adjacent to the Rogers Avenue Pump station. To do so, the Village must first obtain an appraisal in order to make a qualifying offer. The Rogers Avenue tank has been plagued by leaks, and attempts to obtain a grant for replacement have not yet been met with any success. The Village is currently looking into other options.

# Sales Tax Receipts Drop Sharply

Submitted by the Columbia County Board of Supervisors

Columbia County is set to incur a 31 percent decline in sales tax receipts for the May to mid-June time frame compared to this period in 2021, County Treasurer PJ Keeler said today. The percentage decline translates to an actual dollar drop of \$1.8 million.

"This has to do with a huge sales tax distribution reconciliation with New York City – a year ago New York City was not taking in much in the way of sales tax because of its slow recovery from the effects of COVID-19, but now it is recovering rapidly. Because of that, the New York State Department of Taxation and Finance is reconciling distributions to bring things more back in line," said Treasurer Keeler.

"Obviously, we are quite concerned about this development," said Columbia County Board of Supervisors Chairman Matt Murell. "We will continue to monitor the sales tax situation, with an eye on its potential budgetary impacts as well as what effect it will have on day-to-day operations of the County."

Columbia County had been as much as 26 percent ahead of last year, but owing to this reconciliation, it is now down to around 12 percent in the positive this

year. Should this trend continue, the treasurer predicts the County going forward may settle in the three-five percent positive range.

"I don't think the impact has ever been quite this dramatic," said county Controller Jim Breig.

"It's clear that the days of huge sales tax receipts that everyone thought were here, are gone. The outlook is not good," said Treasurer Keeler. "Once again, this is another example of why we budget conservatively."


# **Obituaries**

In his quiet time he enjoyed the pastimes of working on and maintaining his cars and trucks and spending quality time in visits with friends and neighbors.



## The Life of George Holcomb

### George Is Taken Unwell

Saturday, August 7, 1852: Some showery. I and Irish John hoed and weeded in the garden, and I paid Irish John one dollar and at night he went to Lebanon to get his shoes mended and stayed all night. Today I took up a note of 46 dollars and gave a new note of 30 dollars and I paid the balance, 18 dollars and 37 cts to Henry Campbell.

Monday: I went and got Alexander Ostrander two seated one horse wagon for to go to Troy, and today John F. went to Pittsfield and carried twelve bushel potatoes to Stern's Factory on a contract at 75 cts per.

Tuesday: Today John F. took my horse and A. Ostrander's wagon and carried his aunt Miriam Campbell and his cousin Henry Campbell to Troy to take the cars to go west. They all stayed in Troy tonight to Congress Hall. I gave my two daughters 25 dollars to pay their expenses. Today Geo P. and hired help worked on the Maxon farm. Today the widow Freelove Wylie came to stay with my wife while my two daughters were gone their journey. Tonight I am taken quite unwell.

Wednesday: I am quite unwell, so much that I was confined to my bed, I was taken a puking and pain across my bowels. This morning Geo P. walked Uncle Jay Wylie's and stay tonight.

over to Alonzo Rodgers and paid 25 cts for a box of Herrick's pills and I took four of said pills and they puked me. This afternoon James Runnals helped Irish John draw in hay that got caught out yesterday and got wet.

Thursday: I remain unwell but better than I was yesterday. This afternoon my two sons and Irish John got in hay. Thursday: I remain unwell and lame and take more of Herrick's pills. This forenoon John F. cradled oats on the Rodgers farm and John Merrils cradled all day towards house rent. This forenoon Geo P. and Irish John got in the last of my hay.

Saturday: I remain unwell. Today Geo P. went to Lanesborough pond fishing in company with others, he got but a few fish.

Tuesday: I am better of my lameness, I helped unload two loads of oats. Irish John cut briars where we are to build a wall. Today we drew cord wood from off the hill with John F. ox team and sled. I helped some but I am lame. Today Geo P. went to commencement to Williamstown Colleges. Today quite warm.

Friday: Today Geo P. not well. He said that he would ride to Pittsfield to his
