The Ambulance Response Time Problem

Injured or sick, call for an ambulance and keep your fingers crossed one will show up in a reasonable amount of time. That is perhaps a bit of an overstatement, but it bears out the frustration that Brunswick residents, emergency service personnel, and Town officials are feeling. To that end, the Brunswick Town Board held a workshop meeting on Tuesday, August 30, with a representative of the Cambridge Rescue Squad, the County's 911 center coordinator, and members of area fire departments.

Call for an ambulance in Brunswick and the arrival time might be as little as five minutes or perhaps 30 minutes or longer. As was discussed, 30 minutes might be ok if it is not a lifethreatening situation, but what if it is? So what is the root of the problem? The answer is the number of ambulances available in the County at any given time and that is determined by staffing.

The Eastwick Press has reported on the difficulty volunteer and even paid ambulance services are having recruiting and retaining Emergency Medical Technicians (EMT). Part of the problem is the enormous amount of training required just to become an EMT along with volunteer time on a rescue squad. In this day and age, even those willing to give of themselves to their community may not have that much time available.



In 1886, Catherine Burnham's love for children and family motivated her to persuade husband Frederick to donate 580 acres of land and buildings for what she believed was a great cause. The former Shaker community in Canaan, New York, became the Burnham Industrial Farm—a refuge for what were then called wayward boys. The idea that the Farm represented a family, rather than an institution, was a key factor in its success and its positive influence on the boys' lives.

The Farm has had several names since its 1886 founding and is now Berkshire Farm Center & Services for Youth, a large state-wide social service agency serving more than 2,000 children and families every day.

falling by the wayside, with communities like Brunswick depending upon a paid service to fill the gap. Many years ago Brunswick had a volunteer service run by the Eagle Mills Fire Department, but that ceased more than two decades ago. Since then, the Town has relied upon the Mohawk Ambulance Service, for a while paying for Mohawk to garage an ambulance in the Town. That worked relatively well for some time but Mohawk then constructed its own station on McChesney Avenue, able to accommodate up the eight vehicles. Mohawk's initial plans were to try to keep at least one ambulance in the station during the day to serve Brunswick and rural Rensselaer County while the rest were stationed around Troy and other Capital Region localities. According to Brunswick Supervisor Phil Herrington, because of Mohawk's contractual obligations, that is often no longer the case.

Critical Response Times

As was mentioned in the beginning of this report, a minor illness or injury may not require an emergency response but what if it is a stroke or cardiac related? These calls not only require an ambulance, but a paramedic (or ALS) response as well. Besides Mohawk or Empire ambulances, there are only five other ALS ambulance services in the County. So if Mohawk or Empire's paid services are not available, the call rolls to mutual aid. First up for Brunswick, depending on the location, are the Hoosic Valley or North Greensbush ambulances. Hoosick Valley does not have an abundance of staffing and North Greenbush has a high volume of calls in their own town. Thus, they may not have an ambulance available while leaving their own service area protected, and do not respond. The same can be said for the Sand Lake ambulance, leaving the Bruen Rescue Squad in East Greenbush as the only other ALS service available, and there is the added problem of distance as well as availability here. When all ALS services are exhausted, the call rolls to a BLS (EMT) service, with either Grafton or Pittstown usually the first called. But they have their

own staffing problems, and sometimes cannot get an ambulance off the floor.

So Now What?

The Board members talked about two potential solutions. One would be to outright contract with Mohawk to provide a dedicated ambulance for Brunswick, either BLS or ALS. This would be costly, with the Town and Mohawk currently discussing pricing. The other option would be for the Town to form its own ambulance corps, starting small with volunteers, then moving to part-time paid staff and eventually a hybrid of full-time paid personnel and volunteers. This is where the representative from the Cambridge Rescue Squad came into play. Mark Spiezio outlined for the Board members how they started and

What Brunswick would have to do to emulate Cambridge and work with its current EMS fire department response, as well as understand the financial commitment from the Town, will require some more research. Since this meeting happened just hours before press time, the rest of the story will appear in next week's edition.



A Local Law Providing for Implementation of New York State Real Property Tax Law Section 485-v as to County Taxes

Be it enacted by the County Legislature of the County of Rensselaer as follows:

Legislative Intent. Pursuant to recent amendments to Section 485-v of the Real Property Tax Law of the State of New York, as set forth below, the County Taxes for effected and qualifying real property parcels, shall be adjusted accordingly for County Fiscal Year 2023 and thereafter:

Real Property Tax

- *§ 485-v. Residential and mixed-use investment exemption; certain cities and school districts.
- 1. As used in this section:
- "residential and mixed-use real property" means any structure containing one to four units of which one unit may be for commercial or retail use, and the remaining units shall be for residential use;
- "construction" means the creation, modernization, rehabilitation, expansion or other improvement of any structure but shall not include ordinary maintenance or repairs.
- Residential and mixed-use real property constructed on or after the first day of July, two thousand twenty-one located in a city with a population of not less than fifty thousand and not more than fifty-one thousand, based upon the two thousand ten federal census, shall be exempt from city, county and school taxation as provided in this section.
- (a) (i) Such real property shall be exempt for a period of four years to the extent of one hundred per centum of the increase in assessed value thereof attributable to such construction and for an additional period of eleven years provided, however, that the extent of such exemption shall be decreased by twenty-five per centum in year five, ten per centum in each year six through year nine, and five per centum each year during such additional period of six years and such exemption shall be computed with respect to the exemption base. The exemption base shall be the increase in assessed value as determined in the initial year of such fifteen-year period following the filing of an original application, except as provided in subparagraph (ii) of this paragraph.

(ii) In any year in which a change in level of assessment of fifteen percent or more is certified for a final assessment roll pursuant to the rules of the commissioner, the exemption base shall be multiplied by a fraction, the numerator of which shall be the total assessed value of the parcel on such final assessment roll, excluding any additional value derived from any physical or quantity changes to the parcel since the immediately preceding assessment roll, and the denominator of which shall be the total assessed value of the parcel on the immediately pre-ceding final assessment roll. The result shall be the new exemption base. The exemption shall thereupon be recomputed to take into account the new exemption base, notwithstanding the fact that the assessor receives the certification of the change in level of assessment after the completion, verification and filing of the final assessment roll. In the event the assessor does not have custody of the roll when such certification is received, the assessor shall certify the recomputed exemption to the local officers having custody and control of the roll, and such local officers are hereby directed and authorized to enter the recomputed exemption certified by the assessor on the roll. The assessor shall give written notice of such recomputed exemption to the property owner, who may, if he or she believes that the exemption

Harvesting Turnips

Saturday, October 23, 1852: Today Monday: John F. drew stone and plowed, Geo P. sold 74 sheep at one dol 75 cts per to Joseph Runnals and Rufus with turnips five bushels, and cut turnips Monday: I got carrots in the celler and Mrs. Lynch washed for us. helped Geo P. drive his sheep from P. Hatch's to the Maxon farm. John F. by heating and cracking off.

Tuesday: Today John F. heated rocks and broke.

drew stone and this afternoon I and John F. went to a vendue of the propturnips on the Maxon farm. Tonight Geo Wylie and Henry Wylie stayed with us, they were here walnuting.

Thursday: Geo P. worked on the Maxon farm at his turnips, and his hired help, three Irish women helped him. Today the Runnals finished digthe Shakers at 20 cts per bushel.

Saturday: Some rainy. I and John F. worked on the Rodgers farm making fence and repairing the barn doors. This evening my two sons and two daughters went to the school house lecture room to hear Mr. Turner lecture on electricity.

Geo P. went to Lebanon to Kendall's Sweet and is to keep them two weeks. and the three Irish women helped him,

that the Merrils raised on shares, and Tuesday, November 2: This afternoon I and my two sons rode over to Henry Platt's to election. I paid one dollar dug up a rock and got away part of it to the son of Jonathan Carpenter for Elder Maxon.

Wednesday: I drew gravel on the highway with my one horse and wagon and Wednesday: John F. dug rocks and had three days credited. Today my two sons worked drawing in turnips. John F. carried a load carrots to New Lebaerty of Adam Brown. Geo P. gathered non To Edwin Kendall, 22 bushels and Geo P. carried him 35 bushels turnips at 20 cts per and Geo P. carried Walker ten and a half bushel carrots at 25 cts per. Thursday: I worked on the highway with my horse and wagon and had three days credited. This evening I carried my journal up to Mr. John ging their carrots and sold them half to Russell to satisfy him that I worked six days in the highway last June. Today Geo P. worked at his turnips,
