## Workforce Development Career Center Opens at Hudson Valley Community College

On Thursday, October 27, College, State, and County officials gathered for the opening of the new Workforce Development Career Center at Hudson Valley Community College. The Center, which will be a satellite office of the Rensselaer County Career Center, is operated in conjunction with the Capital Region Workforce Development Board, which will also be located on campus. The new Career Center will provide job seekers with customized career planning, resumé assistance, career search workshops, and tuition assistance for short-term training through the federal Workforce Innovation Opportunity Act. The Center will work in partnership with the College's Center for Career and Transfer in providing services that complement and expand the connection between education and workforce placement, and development activities in the region. Local and regional businesses also will have the opportunity to use the Center for recruiting and development of current and future employees.

The Capital Region Workforce Development Board is comprised of private business representatives and public partners whose goal is to strengthen the skills of the Capital Region's workforce through partnerships with business, education, and commu-

nity-based organizations. It sponsors the three Comprehensive Career Centers in the region that offer a variety of programs designed to help adults and youth identify career pathways, job training, placement, and the tools to strengthen their skills to achieve a higher quality of life.

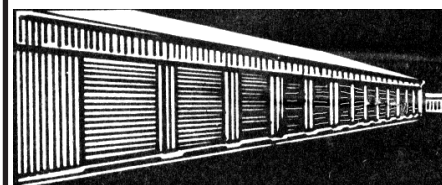

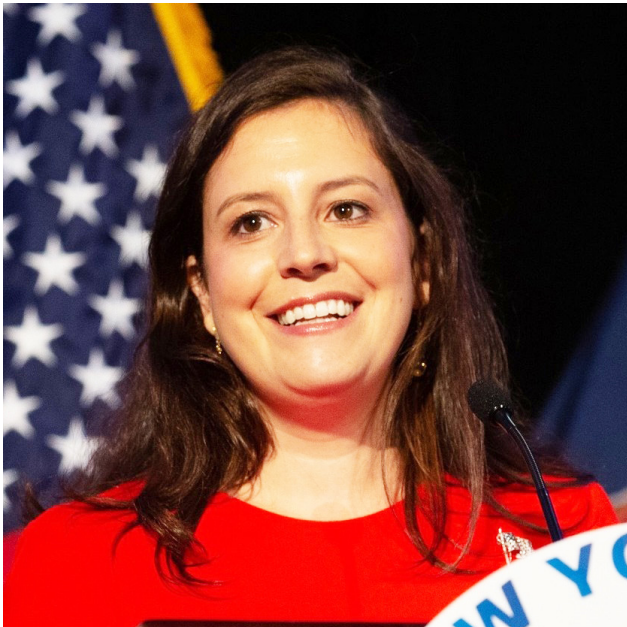

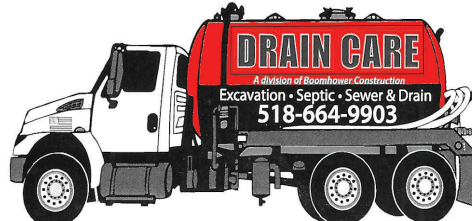

## Taking on the Problem of Food Waste

Charged with finding ways to help their Town mitigate climate change, New Lebanon's Climate Smart Communities Task Force soon realized they needed to take on the problem of food waste. Left over food is a major component, almost a fifth, of the nation's landfills, where it generates 120,000 metric tons of CO<sub>2</sub> and methane, an even more potent greenhouse gas.

Last spring, volunteers began collecting coffee grounds from three local restaurants: Maverick's, Blueberry Hill, and Stewart's. These early adapters accommodated the five-gallon buckets tucked into their kitchens and the volunteers interrupting them daily with empty buckets to switch for the full ones.

Subsequently, volunteers also distributed buckets for food scraps at certain places around Town with the aim of encouraging residents who do not compost to bring their kitchen scraps there.

This green gold being collected is nitrogenous. It will emit methane unless it is mixed with carboniferous material such as wood chips. In order to assure this happens, much of it is transported to the Chatham Convenience Station. There, the Columbia County Solid Waste Department, directed by Jolene Race, distributes it to County farmers for proper composting. The rest of it currently goes to the compost bin at the Community Garden, located next to the Immaculate Conception Church on Route 20.

As the Task Force moves toward their next steps in this project, they have kept at least 52 pounds of food out of the waste stream and into gardens where it will provide microbes necessary for healthy crops.

After starting with this exploratory program, the Task Force hopes to obtain grant money for more extensive and regular food scrap collections in New Lebanon.





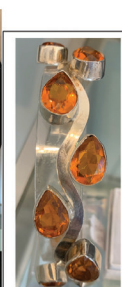
